3. 8 x 2MP cameras will be inside with the minimum range of 20m.
4. All cameras will be wall mounted and controlled in one control room (Placement of camera's will be discussed with a representative of the Agency).
5. Power supply CCTV 18 way 20Amp distribution box.
6. 1 x Monitor LED32" (1366X768) VGA, HDMI, USB and AV Inputs
7. 16 HD DVR unit viewing screen wall mounted and compatible UPS.
8. 8 Terabyte hard drive and the rack for the DVR.
